

## MONOPOLY Multiplier Second Chance Drawing from the Arizona Lottery (effective December 30, 2024)

This promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by law outside the State of Arizona.

### Game Period

The Arizona Lottery (the "Lottery") is conducting an online Promotion (the "Promotion"). The Promotion period begins on December 30, 2024, at 12:00:01 a.m. (Arizona Time), and continues until March 31, 2025, 11:59:59 p.m. (Arizona Time).

### How to Enter the Promotion

1. A player may enter the Promotion by: 1) going to [arizonalottery.com](http://arizonalottery.com) and clicking on the Players Club link; 2) going directly to the Players Club website at [azplayersclub.com](http://azplayersclub.com) (the "Website"); or 3) using the Arizona Lottery Players Club mobile app (the "Mobile App").
2. A player must complete the required registration information and confirm that the player is: 1) twenty-one (21) years of age or older; 2) has voluntarily waived confidentiality rights under A.R.S. § 5-573(D); and 3) has read the Official Rules of the Promotion.
3. To enter the Promotion, a player must purchase at least one (1) designated Lottery instant scratch game ticket (each a "Game Ticket") from an authorized Arizona Lottery Retailer during the Promotion period. Eligible games for the Promotion are as follows:

4. Eligible games are subject to change. Any changes will be posted on the Website and Mobile App as they become available. Sale dates and draw dates are subject to change.
5. A player must submit the required entry information from an eligible winning or non-winning Game Ticket.
6. It is the responsibility of a player to enter any winning tickets into their Players Club account **prior** to redeeming with a retailer. Upon claiming a prize, the retailer may keep the validated winning ticket and the required entry information may no longer be available to the player. A Game Ticket entered into the Website or Mobile App must still be brought to an authorized Arizona Lottery retail location to claim any original game prizes.
7. For purposes of the Promotion, a player is not required to retain a Game Ticket once it has been successfully entered via the Website or Mobile App and the entry is shown in the Player's History. Please allow up to 48 hours for scanned tickets to sync with the platform and appear in the account history.
8. Players may enter each Drawing multiple times but must have a separate Game Ticket for each entry. A Game Ticket may be entered only one (1) time.

9. Players will receive one entry per dollar spent on each eligible ticket entered. The number of entries a player could receive for all other eligible Game Tickets will be determined as shown in the following table:

10. During the Promotion period, the Lottery may add special features to the Promotion allowing a player to receive additional entries for Game Tickets entered into the Promotion. Such special features may include, but are not limited to, double entries on a specific day, specific Game Ticket combinations for “super entries,” or any other special requirements designed to increase sales or awareness of the Games. Any special features will be noted on the Website.
11. Players may enter up to a total of fifty (50) eligible Game Tickets per day into the Website and Mobile App. For purposes of this Promotion, a day is defined as that period of time which starts at 12:00:01 a.m. (Arizona Time) and ends at 11:59:59 p.m. (Arizona Time).
12. An entry received during a specified entry period is only eligible for the corresponding Drawing. Entries cannot be submitted after the entry deadline.
13. Entries must be submitted using the Website or Mobile App. Mail-in entries, hand-delivered entries, or entries dropped off at the Lottery offices will not be accepted.
14. If a dispute arises over the eligible entrant, the named player of the email account associated with the entry registration will be the official entrant.

## Drawings

1. One (1) Drawing will be held. The Drawing date and entry periods are as follows:

All times referenced in the chart above are Arizona Time.

2. Five winners and fifteen alternates will be selected in Draw #1. There will be one Grand Prize winner and four secondary prizewinners (collectively the “Prizewinners”).
3. If a selected winning entry is determined to be invalid, and thus disqualified, the next available alternate will become eligible to assume the prize. In the event the Prizewinner and initial alternates are disqualified, additional alternates will be selected from the same pool of entrants used for the Drawing.
4. Prizewinners shall be notified via email and/or phone by the Lottery or its designee within seven (7) calendar days after the Drawing. The Prizewinner list is subject to change based on verification of the Prizewinners by the Lottery.
5. The Prizewinners name and town of residence will be posted on the Website and Mobile App following the confirmation of all Prizewinners of the Promotion.
6. Prizewinners shall be randomly selected from all valid Website and Mobile App entries received for the Drawing.
7. The Drawing will be conducted by Pollard Banknote Limited at their offices at 1499 Buffalo Place, Winnipeg, Manitoba, Canada. The Drawing location may change at the discretion of the Lottery.
8. The Drawing date and the number of Drawings are subject to change at the discretion of the Lottery.

## Prizes

1. A player is eligible to win only one (1) prize for this Promotion.
2. The prize description and number of winners is as follows:

3. Each cash prize is subject to Federal and State taxes.
4. The odds of winning vary, based on the total number of entries received for the Drawing and the total number of entries a player submits.
5. The Lottery is not responsible for compromised, inaccessible or insecure email accounts and no deadline extension will be offered in the event that an account is compromised.

## Entry Eligibility Requirements

1. All Drawing entries are subject to validation by the Lottery or its designee and may be disqualified if eligibility requirements are not met.
2. A player must be twenty-one (21) years of age or older to purchase a Game Ticket and enter the Promotion.
3. Players, Game Tickets, transactions, and Prizewinners are subject to laws of the State of Arizona, all Lottery Official Rules, orders of the Lottery Commission, the Terms of Use and the Privacy Policy on the Website, the Lottery drawing procedures, and any applicable Federal laws affecting the Promotion.

## Disqualification

1. A.R.S. § 5-575 requires winners of a prize valued at \$600 or more reviewed to determine if that winner owes money to certain State of Arizona entities. If any such debts exist, the Lottery is required to offset a Player's cash prize by the amount of the debt.
2. "Ineligible Player" is a person who is directly employed by the Arizona Lottery or a Familial Person (e.g., spouse, children, parents, siblings, housemates, roommates, friends and/or romantic partners) whose principal residence is the same as such Arizona Lottery employee. Such person is prohibited from participation in Arizona Lottery games. Additionally, any vendor or contractor who is responsible for supplying gaming equipment or Arizona Lottery tickets, advertising, consulting services, who participates in any way with the drawings or otherwise selecting winning Arizona Lottery tickets or who has access to secured Arizona Lottery locations or a Familial Person (e.g., spouse, children, parents, siblings, housemates, roommates, friends and/or romantic partners) whose principal residence is the same as such vendor or contractor or the immediate supervisor of such vendor or contractor is an Ineligible Player and is prohibited from participation in Arizona Lottery games.
3. The Lottery and/or its administrators, at their sole discretion, may disqualify a player, Prizewinner, or designee from participating in any aspect of the Promotion if they deem or suspect that such person has engaged in or has attempted to engage in any of the following: (a) acting in violation of the law, these Official Rules, or the Terms of Use or Privacy Policy; (b) damaging, tampering with or corrupting the operation of the Website or Mobile App; (c) acting with intent to annoy, harass, or abuse any other person; (d) using any automated bot, macro, script, or other robotic, mechanical, programmed or automated devices to submit data or spam to the Website or Mobile App; (e) making repeated attempts to submit invalid multiple entries; (f) participating in any unsportsmanlike, inappropriate, uncooperative, disruptive, fraudulent, or potentially fraudulent behavior or activity; or (g) participating in any activity

deemed to be generally inconsistent with the intended operation of the Promotion. CAUTION: ANY ATTEMPT BY A PERSON TO DELIBERATELY DAMAGE OR CORRUPT ANY OF THE LOTTERY'S WEBSITES OR UNDERMINE THE LEGITIMATE OPERATION OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, THE LOTTERY AND ITS ADMINISTRATORS RESERVE THE RIGHT TO SEEK CRIMINAL PROSECUTION AND SEEK DAMAGES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT OF THE LAW.

### **Use of Personal Information**

1. The collection, use, storage, and destruction of personal information submitted by a player for participation in the Drawings will be managed in accordance with the Privacy Policy and the Terms of Use of the Website.
2. A player is required to be twenty-one (21) years of age or older to provide information that will be collected on the Website.
3. By submitting a drawing entry on the Website or via the Mobile App, a player gives the Lottery permission to announce and publish the player's name, city and state for marketing/promotional purposes if the player wins a prize. Because a second chance drawing is exclusively used as a promotional event, a person who participates in a second chance drawing is deemed to have voluntarily waived the confidentiality rights under A.R.S. § 5-573(D). A player who does not want to consent to immediate release of his or her name as a winner should not participate in this Promotion, will be ineligible to receive a prize in a second chance drawing, and will be disqualified if chosen as a winner, resulting in selection of an alternate winner.

### **Claiming Requirements**

1. Prizewinners must provide their legal name and address. For prizes of \$600 or more, Prizewinners must complete a Winner Claim Form, provide their taxpayer ID (typically their social security number), provide a form of government-issued photo identification, and pass all validation checks prior to claiming their prize. Each Prizewinner is responsible for including the prize when filing their state, federal, and/or local taxes. Prizewinners must claim their prize within seven (7) calendar days from the prizewinner notification date by the Lottery. If all reasonable efforts to locate a Prizewinner fail within the seven (7) calendar-day period, the Lottery may select a replacement winner as previously described.
2. Disqualification, forfeiture, and the selection of an alternate potential winners may result from any of the following: (a) the potential Prizewinner's failure to respond to any notification within the specified response period; (b) the return of an email notification as undeliverable after three (3) attempts; (c) the return of any other notice as undeliverable; (d) the potential winner's failure to provide satisfactory proof of age, identity, and residency; (e) the potential winner's failure to execute and return the required documents (including, without limitation, the Winner Claim Form) within the specified return period; (f) the potential winner's failure to be available to receive the prize; (g) the potential Prizewinner's failure to validly claim the prize by the date specified in the prize award notification; or (h) any other non-compliance with the law, these Official Rules, the Terms of Use, or the Privacy Policy. In the event of a forfeiture of the prize, the Lottery may, in its sole discretion, award or not award the forfeited prize to an alternate winner.

### **Miscellaneous**

1. Approximately one hundred eighty (180) days after the completion of the Promotion, all non-winning, non-selected and/or ineligible entries shall be deleted.
2. The Lottery reserves the right, in its sole discretion, to modify these Official Rules without materially

affecting the terms and conditions of the Promotion. The Lottery reserves the right to modify, cancel, postpone, delay, suspend, and/or terminate this Promotion, in whole or in part, in the event that the Promotion is not capable of running as planned or as intended by these Official Rules, by reason of any technical or other disabling causes, or other causes that impair, corrupt, or interrupt the administration, fairness, security, integrity, or proper play of the Promotion, including, without limitation, hurricane, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, war, terrorist threat, or activity or insurrection. In such an event, the Lottery may, in its sole discretion: (a) postpone and/or reschedule and/or modify the Promotion, or (b) cancel the Promotion in its entirety. In the event of cancellation, the Lottery shall award the prizes through a process deemed fair and equitable by the Lottery, in its sole discretion, and the Lottery and its administrators shall have no further liability to any participant in connection with the Promotion. In no event will the Lottery be obligated to award more prizes than the number of prizes stated in these Official Rules.

3. Whether caused by a player, equipment, or programming associated with or utilized in this Promotion, or by any technical or human error that may occur in the processing of entries, the Lottery, Pollard Banknote Limited, nor Hasbro, Inc. are not responsible for inaccurate entry information or errors that may occur in the processing of the Promotion that may be the result of: (a) error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries; or (b) lost, misdirected, late, incomplete, corrupted, illegible, or unintelligible entries. Corrupted, illegible, unintelligible, or incomplete entries are void.
4. The Lottery reserves the right to substitute prizes with similar merchandise of equal or greater value. No prize substitution, cash equivalent, or transfer of prize by a winner in violation of these Official Rules is permitted. By accepting a prize, a player agrees to release the Lottery, Pollard Banknote Limited and Hasbro, Inc. (the "Released Parties") from, and shall hold them harmless against, any liability, loss, claims, injury, or damage to property or to person, including death, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of the prizes or participation in this Promotion, even if caused or contributed to by the negligence of the Released Parties.
5. This Promotion is governed by laws and regulations of the State of Arizona, and all players hereby submit to the exclusive jurisdiction and venue of the State of Arizona for resolution of all claims and disputes through administrative hearing, and any right to a trial by jury is hereby waived. Any and all disputes, claims, and causes of action arising out of or connected with this Promotion or any prize awarded are governed by Arizona Administrative Code ("A.A.C.") § R19-3-1008. The decision of the Lottery is final. Any decision by the Lottery Director is a final, appealable agency action to the Office of Administrative Hearings under the procedures of A.A.C. § R2-19-101 through § R2-19-122. Exhaustion of administrative remedies applies.
6. If any provision or provisions of these Official Rules, the Terms of Use, or the Privacy Policy is, or will be, held to be invalid, illegal, unenforceable, or in conflict with the law of any jurisdiction, the validity, legality, and enforceability of the remaining provisions will not in any way be affected or impaired thereby. The Lottery's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
7. Players or interested parties must use the Feedback form for any questions or comments they may have about this Promotion.

## **MONOPOLY Multiplier – Players Club Promotion FAQs**

### **Questions about entries and tickets**

**Q: Which tickets can be entered into this Promotion?**

A: Eligible games are listed on the promotion page. Only winning and non-winning tickets from the designated games can be entered into the Promotion.

**Q: How long does the promotion run?**

A: The promotion period begins on December 30, 2024 and continues until March 31, 2025. Any changes to the promotion period will be posted on the Website and Mobile App.

**Q: How many entries do I get for each ticket I enter?**

A: The total number of entries each ticket will receive varies based on the purchase price of the ticket. Players will receive one entry per dollar spent on each ticket entered.

### **Questions about winners**

**Q: How are the winners selected?**

A: Winners will be randomly selected from all entries received for each drawing.

**Q: What are the prizes for the MONOPOLY Multiplier Promotion?**

A: Prizes are listed on the promotion page.

**Q: Can I win a prize more than one time?**

A: No. A player may win one time during this Promotion.

**Q: Can I win if I live outside of the boundaries of Arizona?**

A: Yes. Players who live outside of the boundaries of the state of are eligible to participate in the MONOPOLY Multiplier Promotion. All eligible tickets must be purchased from an official Arizona Lottery retailer.
