

Arizona Lottery – CASH CASTLE Promotion

(effective December 30, 2025)

This Promotion is valid only within the State of Arizona and is void where prohibited by law. It is in no way sponsored, endorsed, or administered by, or associated with, Apple Inc., Google LLC, or any other third-party application provider.

Game Period

The Arizona Lottery (the "Lottery") is conducting an online Promotion (the "Promotion"), which will run from on December 30, 2025, at 12:00:01 a.m. (Arizona Time) through March 31, 2026, 11:59:59 p.m. (Arizona Time).

How to Enter the Promotion

1. A player may enter the Promotion by: 1) going to arizonalottery.com and clicking on the Players Club link; 2) going directly to the Players Club website at azplayersclub.com (the "Website"); or 3) using the Arizona Lottery Players Club mobile app (the "Mobile App").
2. A player must complete the required registration information and confirm that the player is: 1) twenty- one (21) years of age or older; 2) has voluntarily waived confidentiality rights under A.R.S. § 5- 573(D); and 3) has read the Official Rules of the Promotion.
3. To enter the Promotion, a player must purchase at least one (1) designated Lottery game ticket (each "Game Ticket") from an authorized Arizona Lottery Retailer during the Promotion period. Eligible games for the Promotion are as follows:

4. Eligible games are subject to change. Any changes will be posted on the Website and Mobile App as they become available. Sale dates and draw dates are subject to change.
5. A player must submit the required entry information from an eligible winning or non-winning Game Ticket.
6. Upon claiming a prize, it is the responsibility of a player to enter any winning tickets into their Players Club account prior to redeeming with a retailer. A Game Ticket entered into the Website or Mobile App must still be brought to an authorized Arizona Lottery retail location to claim any original game prizes.
7. To participate in the Promotion, players must enter a valid Game Ticket via

the Lottery Website or Mobile App. Players must retain their Game Ticket until they have verified that the entry appears within their Player's History. Please note that while most entries appear instantly, it may take up to forty-eight (48) hours for an entry to be reflected in the Player's History.

8. Players may enter each Drawing multiple times but must have a separate Game Ticket for each entry. A Game Ticket may be entered only one (1) time.
9. Players will receive entries based on the purchase price of each eligible ticket entered. The number of entries a player receives for each eligible Game Ticket will be determined as shown in the following table.

10. During the Promotion period, the Lottery may add special features to the Promotion allowing a player to receive additional entries for Game Tickets entered into the Promotion. Such special features may include, but are not limited to, double entries on a specific day, specific Game Ticket combinations for "super entries," or any other special requirements designed to increase sales or awareness of the Games. Any special features will be noted on the Website.
11. Players may enter up to a total of fifty (50) eligible Game Tickets per day into the Website and Mobile App. For purposes of this Promotion, a day is defined as that period of time which starts at 12:00:01 a.m. (Arizona Time) and ends at 11:59:59 p.m. (Arizona Time).
12. An entry received during a specified entry period is only eligible for the corresponding Drawing. Entries cannot be submitted after the entry deadline.
13. Entries must be submitted using the Website or Mobile App. Mail-in entries, hand-delivered entries, or entries dropped off at the Lottery offices will not be accepted.
14. If a dispute arises over the eligible entrant, the named player of the email account associated with the entry registration will be the official entrant.

Relationship Between Promotional Entry and Prize Claims

- **Promotional Entry vs. Prize Claim:** Entering a Game Ticket into this Promotion via the Website or Mobile App is for a chance to win a promotional prize only. This action is separate from, and does not replace, the process for claiming a cash prize associated with the same Game Ticket.

- **Claiming a Cash Prize:** To claim a cash prize, the player must present the original physical Game Ticket to the Arizona Lottery offices or an authorized Arizona Lottery Retailer for validation and payment.
- **Player Responsibility:** For the best experience, players are encouraged to enter their winning Game Tickets into the Promotion *before* presenting them to a retailer for prize payment. The Arizona Lottery is not responsible for any inability to enter a ticket into the Promotion that has already been claimed or lost.

Drawings

1. One (1) Drawing will be held. The Drawing date and entry period are as follows:

All times referenced in the chart above are Arizona Time.

2. Fifty (50) winners and one hundred fifty (150) alternates will be selected.
3. Players can access confirmation of entry into any Drawing during the Promotion period via Website or Mobile App in their Players Club account under their Player History.
4. If a selected winning entry is determined to be invalid, and thus disqualified, the next available alternate will become eligible to receive the prize. In the event the Prizewinner and initial alternates are disqualified, additional alternates will be selected from the same pool of entrants used for the Drawing.
5. Prizewinners shall be notified via email and/or phone by the Lottery or its designee within seven (7) calendar days after the Drawing. The Prizewinner list is subject to change based on verification of the Prizewinners by the Lottery.
6. The Prizewinners name and town of residence will be posted on the Website and Mobile App following the confirmation of all Prizewinners of the Promotion.
7. Prizewinners shall be randomly selected from all valid Website and Mobile App entries received for each Drawing.
8. The Drawings will be conducted by Pollard Banknote Limited at their offices at 1499 Buffalo Place, Winnipeg, Manitoba, Canada. The Drawing location may change at the discretion of the Lottery.
9. Drawing dates and the number of Drawings are subject to change at the discretion of the Lottery.

Prizes

1. A player is eligible to win only one (1) prize for this Promotion.
2. The prize description and number of winners is as follows:

3. The odds of winning vary, based on the total number of entries received for a Drawing and the total number of entries a player submits.
4. The Lottery is not responsible for compromised, inaccessible or insecure email accounts and no deadline extension will be offered in the event that an account is compromised.

Entry Eligibility Requirements

1. All Drawing entries are subject to validation by the Lottery or its designee and may be disqualified if eligibility requirements are not met.
2. To be eligible to purchase an Arizona Lottery Game Ticket and to enter this Promotion, a player must be twenty-one (21) years of age or older.
3. By entering the Promotion, each player agrees to be bound by and comply with the following, which shall govern all aspects of the Promotion:
 - These Official Promotion Rules;
 - All applicable laws, statutes, and regulations of the State of Arizona and the United States;
 - All official rules, policies, order, and drawing procedures of the Arizona Lottery; and

- The Arizona Lottery Website's Terms of Use and Privacy Policy.
- In the event of any discrepancy between these Official Promotion Rules and any other information or governing document, these Official Promotion Rules shall control.

Disqualification

1. A.R.S. § 5-575 requires winners of a prize valued at \$600 or more reviewed to determine if that winner owes money to certain State of Arizona entities. Prizewinners who are identified as owing debt to a State of Arizona entity will be disqualified and an alternate will be selected.
2. Players prohibited from participating in Lottery games pursuant to A.R.S. § 5-567.
3. The Lottery, at its sole discretion, may disqualify a player, Prizewinner, or designee from participating in any aspect of the Promotion if they deem or suspect that such person has engaged in or has attempted to engage in any of the following: (a) acting in violation of the law, these Official Rules, or the Terms of Use or Privacy Policy; (b) damaging, tampering with or corrupting the operation of the Website or Mobile App; (c) acting with intent to annoy, harass, or abuse any other person; (d) using any automated bot, macro, script, or other robotic, mechanical, programmed or automated devices to submit data or spam to the Website or Mobile App; (e) making repeated attempts to submit invalid multiple entries; (f) participating in any unsportsmanlike, inappropriate, uncooperative, disruptive, fraudulent, or potentially fraudulent behavior or activity; or (g) participating in any activity deemed to be generally inconsistent with the intended operation of the Promotion. **Caution: Any attempt by a person to deliberately damage or corrupt any of the lottery's websites or undermine the legitimate operation of the Promotion is a violation of criminal and civil laws. Should such an attempt to be made, the lottery and its administrators reserve the right to seek criminal prosecution and seek damages from any such individual to the fullest extent of the law.**

Use of Personal Information

1. The collection, use, storage, and destruction of personal information submitted by a player for participation in the Drawings will be managed in accordance with the Privacy Policy and the Terms of Use of the Website.
2. A player is required to be twenty-one (21) years of age or older to provide information that will be collected on the Website.
3. **Winner Publicity and Waiver of Confidentiality**
 - **Consent to Publicity:** By entering this Promotion, each player consents to and grants **the Lottery** permission to announce and publish their name, city, and state of residence for any marketing, promotional, or other purpose related to the Promotion, should they be selected as a prize winner.

- **Voluntary Waiver of Confidentiality:** This is a second-chance Promotional drawing. Therefore, pursuant to A.R.S. § 5-573(F), participation in this Promotion constitutes a voluntary waiver of the prize winner confidentiality rights provided under A.R.S. § 5-573(D).
- **Requirement to Participate:** Any player who does not agree to the public release of their winner information as described above will be ineligible to participate in this Promotion. If such a player is selected, they will be disqualified, and the Lottery will select an alternate winner.

Claiming Requirements

1. Prizewinners must provide their legal name and address. For prizes of \$600 or more, Prizewinners must complete a Winner Claim Form, provide their taxpayer ID (typically their social security number), provide a form of government-issued photo identification, and pass all validation checks prior to claiming their prize. Each Prizewinner is responsible for including the prize when filing their state, federal, and/or local taxes. Prizewinners must claim their prize within seven (7) calendar days from the prizewinner notification date by the Lottery. If all reasonable efforts to locate a Prizewinner fail within the seven (7) calendar-day period, the Lottery, in its sole discretion, may select a replacement winner as previously described.
2. Disqualification, forfeiture, and the selection of an alternate potential winners may result from any of the following: (a) the potential winner's failure to respond to any notification within the specified response period; (b) the return of an email notification as undeliverable after three (3) attempts; (c) the return of any other notice as undeliverable; (d) the potential winner's failure to provide satisfactory proof of age, identity, and residency; (e) the potential winner's failure to execute and return the required documents (including, without limitation, the Winner Claim Form) within the specified return period; (f) the potential winner's failure to be available to receive the prize; (g) the potential winner's failure to validly claim the prize by the date specified in the prize award notification; or (h) any other non-compliance with the law, these Official Rules, the Terms of Use, or the Privacy Policy. In the event of a forfeiture of the prize, the Lottery may, in its sole discretion, award or not award the forfeited prize to an alternate winner.
3. All applicable taxes will be withheld from cash prizes won during Travel Prize and a W-2 will be issued for any winnings over \$500 within 30 business days.

Miscellaneous

1. Approximately one hundred eighty (180) days after the completion of the Promotion, all non-winning, non-selected and/or ineligible entries shall be deleted.
2. **Modification of Rules:** The Lottery reserves the right, in its sole discretion, to modify these Official Rules at any time without materially affecting the terms and conditions of the Promotion.

3. **Suspension or Termination of Promotion:** The Lottery reserves the right to modify, suspend, or terminate this Promotion if it determines, in its sole discretion, that the Promotion cannot be executed as intended for any reason. Such reasons include, but are not limited to, any cause beyond the Lottery's reasonable control, such as technical failures, fraud, or force majeure events (e.g., fire, flood, epidemic, pandemic, earthquake, act of God, or public enemy).
4. **Procedure Upon Cancellation:** In the event of an early cancellation, the Lottery will endeavor to award the stated prizes in a manner deemed fair and equitable by the Lottery. Upon such an award, the Lottery shall have no further liability to any participant in connection with this Promotion.
5. **Limitation on Prizes:** In no event will the Lottery be obligated to award more than the stated number of prizes in these Official Rules.
6. Whether caused by a player, equipment, or programming associated with or utilized in this Promotion, or by any technical or human error that may occur in the processing of entries, the Lottery, Pollard Banknote Limited are not responsible for inaccurate entry information or errors that may occur in the processing of the Promotion that may be the result of: (a) error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries; or (b) lost, misdirected, late, incomplete, corrupted, illegible, or unintelligible entries. Corrupted, illegible, unintelligible, or incomplete entries are void.
7. The Lottery reserves the right to substitute prizes with similar merchandise of equal or greater value. No prize substitution, cash equivalent, or transfer of prize by a winner in violation of these Official Rules is permitted. By accepting a prize, a player agrees to release the Lottery and Pollard Banknote Limited from, and shall hold them harmless against, including but not limited to, any liability, loss, claims, injury, or damage to property or to person, including death, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of the prizes or participation in this Promotion, even if caused or contributed to by the negligence of the Lottery and Pollard Banknote Limited.
8. This Promotion is governed by laws and regulations of the State of Arizona, and all players hereby submit to the exclusive jurisdiction and venue of the State of Arizona for resolution of all claims and disputes through administrative hearing, and any right to a trial by jury is hereby waived. Any and all disputes, claims, and causes of action arising out of or connected with this Promotion or any prize awarded are governed by Arizona Administrative Code ("A.A.C.") § R19-3-1008. The decision of the Lottery is final. Any decision by the Lottery Director is a final, appealable agency action to the Office of Administrative Hearings under the procedures of A.A.C. § R2-19-101 through § R2-19-122. Exhaustion of administrative remedies applies.
9. If any provision or provisions of these Official Rules, the Terms of Use, or the Privacy Policy is, or will be, held to be invalid, illegal, unenforceable, or in conflict with the law of any jurisdiction, the validity, legality, and enforceability of the remaining provisions will not in any way be affected or impaired thereby. The Lottery's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Players or interested parties must use the Feedback form for any questions or comments they may have about this Promotion.

11. All trademarks are the property of their respective owners.

CASH CASTLE
TRIP PRIZE TERMS AND CONDITIONS

Winner must travel on or about December 10, 2026 through December 16, 2026, to participate in the Cash Castle Trip Prize (“Trip Prize”). If Winner is unable to or will not travel on the dates and times selected by the Arizona Lottery (“Lottery”), the selected Winner will forfeit the Trip Prize, and another Winner will be selected from among eligible entries received, time permitting. Winner and his or her guest (“Guest”) must travel on same itinerary. Winner and Guest must be 21 years of age at the time the Trip Prize is awarded.

In the event that Winner has a debt with the State of Arizona, the Winner will be disqualified, and an alternate Winner will be selected.

All other costs and expenses involved with or related to acceptance and/or participation in the Trip Prize not specifically included in the description of the Trip Prize, including, without limitation, ground transportation, transfers, additional hotel amenities (i.e., spa services, internet access, phone calls, laundry services), fees and gratuities, airline change fees, airline premium seat fees, airline baggage fees (both checked and carry on), and personal expenses such as laundry, valet service, photos, souvenirs, and other incidentals, are the sole responsibility of Winner and Guest. Winner may be required to submit a valid major credit card to the hotel to cover all expenses not specifically awarded as part of the Trip Prize. Travel and hotel accommodations are subject to availability.

The date and location of any of the events or activities included in the Trip Prize (individually/collectively, “Event(s)”) may be subject to change. Lottery is not responsible if any event is delayed, postponed, or cancelled for any reason, in whole or in part, and in such event, Lottery’s only obligation is to award the other elements of the Trip Prize. No compensation will be paid in lieu of any cancelled Event or any other element of the Trip Prize.

In order to participate in the Trip Prize, Winner must execute all releases and forms required by Lottery and agree to comply with all current federal, state, and/or local government and/or agency, or Lottery laws, regulations, restrictions, guidelines, and/or protocols (collectively, “Prize Requirements”). Winner may appoint a proxy to travel to Ireland and participate in the Cash Castle Game Show (“Game Show”) and any other Event cash drawings, subject to the proxy’s satisfying the Prize Requirements. Winner must execute and return all required documentation within five (5) days of Winner’s receipt. Failure to respond and/or execute and return such documentation by the specified deadline(s) may result in forfeiture of the Trip Prize.

- If Winner appoints a proxy, the proxy must satisfy the Prize Requirements in order to participate in the Trip Prize. In the event that Winner’s designated proxy does not satisfy the Prize Requirements, Lottery reserves the right, in its

sole discretion, either to (i) allow Winner to appoint another proxy to participate in the Trip Prize in the Winner's place (subject to Lottery's production schedule and deadlines and satisfying the Prize Requirements); (ii) or appoint another proxy (selected by Lottery) to participate in the Trip Prize in the Winner's (or proxy's) place, or (iii) the selected Winner will forfeit the Trip Prize, and another Winner will be selected from among eligible entries received, time permitting.

- If Winner appoints a proxy (or has a proxy appointed), Winner will still remain eligible to win any prizes during the Game Show and/or any other Event cash drawings.

Guest must also execute all releases and forms required by Lottery and comply with all applicable federal, state, and local government and/or agency laws, rules, orders, and regulations as well as Lottery's rules, regulations, and/or safety guidelines.

Winner and Guest must also comply with all of the rules and regulations of the venues where the Events are held. Winner acknowledges that if Winner and/or Guest behaves in a disorderly or disruptive manner or with intent to annoy, abuse, threaten, or harass any other person at any Event, Winner and/or Guest may be removed from the venue or denied entry (as determined by Lottery or its designee(s) in their sole and absolute discretion). By accepting any ticketed portion of the Trip Prize, Winner agrees to abide by any terms, conditions, and restrictions provided by the ticket. Lost, mutilated, or stolen tickets, vouchers, certificates, or pre-paid gift cards will not be replaced.

No prize element substitution, cash substitution, assignment, or transfer of the Trip Prize or any elements thereof is permitted. Any unused elements of the Trip Prize will be forfeited, will not be redeemable for cash, and may not reduce the prize value awarded for tax purposes. Notwithstanding the foregoing:

- If Winner misses their flight for any reason, reasonable efforts will be used to reschedule the flight at the Winner's expense. If the flight is not able to be rescheduled in a reasonable time for Winner's participation in the Events, (i) Winner shall forfeit and not participate in the travel portion of the Trip Prize, including the Events; (ii) Winner will still receive the Gift Bags (less any tax withholdings, if applicable); and (iii) Winner will remain eligible to win any prizes during the Game Show and/or any other Event cash drawings.

- If Winner is unable to travel in connection with the Trip Prize for any reason after tickets have been booked, (i) Winner shall forfeit and not participate in the travel portion of the Trip Prize, including the Events; and (iii) Winner will remain eligible to win any prizes during the Game Show and/or any other Event cash drawings

- If Winner or proxy fails to attend the Game Show, Winner will remain eligible for any potential Game Show prizes. However, if Winner or proxy fail to attend any other Event cash drawing the Winner or proxy will be ineligible to win any prizes.

In any of the foregoing events, a proxy may be appointed to accept any prizes

won during the Game Show on Winner's behalf at the time of the Game Show; however, in such event, Winner will still receive the Game Show prize (less any tax withholdings).

Winners who do not elect to take a guest, or whose Guest, for any reason, does not actually take the trip, are still subject to the full amount of any taxes due on the total value of the Trip Prize.

Failure to respond and/or execute and return required releases, forms, and other documentation and/or failure to collect, properly claim, respond, and/or cooperate in the acceptance, receipt, delivery, and/or fulfillment of any element of the Trip Prize may result in forfeiture of the Trip Prize or the applicable element thereof, as Lottery may determine in its sole discretion. If forfeited for any reason, Winner will not receive any other prize substitution or compensation of any kind, and Lottery may award the Trip Prize to an alternate recipient as it may determine in its sole discretion. If the Trip Prize cannot be fulfilled due to any federal, state, and/or local government and/or agency, network, or Lottery restrictions, regulations, guidelines, or risk assessments, Lottery reserves the right, in its sole and complete discretion, to substitute an alternate or substitute prize of reasonably comparable value as determined by Lottery in its sole discretion.

Notwithstanding anything to the contrary herein, officers, directors, members, managers, employees, and contractors of the Lottery and members of the immediate family (e.g., parents, spouse, children, siblings, grandparents, stepparents, stepchildren, and stepsiblings and their respective spouses, regardless of where they reside) of any of the foregoing individuals are ineligible to participate in the Cash Castle Promotion and/or win a Trip Prize and/or any of the Game Prizes.

Arizona Lottery and/or the State of Arizona are not responsible or liable, in any way, for any personal injuries, death, property damage, or other damages or expenses resulting from or arising out of any acceptance, fulfillment, loss, use, or misuse of the Trip Prize, any element thereof, and/or any game prizes. Arizona Lottery and or the State of Arizona make no, and are not responsible in any manner for any warranties, representations, or guarantees of any kind, express or implied in fact or law, relating to any elements of the Trip Prize, regarding the use, value, or enjoyment of any elements of the Trip Prize, including, without limitation, its quality, merchantability, or fitness for a particular purpose, and all such warranties are hereby disclaimed.

CASH CASTLE - FAQs

Questions about entries and tickets

Q: Which tickets can be entered into this Promotion?

A: Eligible games are listed on the promotion page. Only winning and non-winning tickets from the designated games can be entered into the Promotion.

Q: How long does the promotion run?

A: The promotion period begins on December 30, 2025, 12:00:01 a.m. (Arizona Time) and continues until March 31, 2026, 11:59:59 p.m. (Arizona Time). Any changes to the promotion period will be posted on the Website and Mobile App.

Q: How many entries do I get for each ticket I enter?

A: Players will receive one entry for each dollar spent to purchase the eligible ticket entered.

Questions about winners

Q: How many winners will be selected?

A: The number of winners selected for each prize is detailed on the chart on page four of the official Rules.

Q: How are the winners selected?

A: The winner will be randomly selected from all entries received for the drawing.

Q: Can I win a prize more than one time?

A: Players can only be selected once per drawing. Players can be selected in multiple drawings.

Q: Can I win if I live outside of the boundaries of Arizona?

A: Yes. Players who live outside of the boundaries of the state of are eligible to participate in Cash Castle. All eligible tickets must be purchased from an official Arizona Lottery retailer.
